Preparation for the follow up to the Strategic Plan for Biodiversity 2011-2020

Thank you Chair,

The IIFB would like to thank the Secretariat for the preparation of the documents for this item. We would like to remind the CBD of the publication, Local Biodiversity Outlook which is complementary to the Global Biodiversity Outlook and point out that sadly, it is not mentioned throughout the document.

Therefore, we would like to make the changes to the Mandate and Relevant Decision to read:

11. Subsidiary Body on Scientific, Technical and Technological Advice regarding scenarios for the 2050 vision for biodiversity, work related to the fifth edition of the *Global Biodiversity Outlook*, **as well as the second edition of the Local Biodiversity Outlook** and relevant work under other multilateral environmental agreements and under the IPBES.
12. The visual diagram outlining the different formal Convention process that will contribute to the development of a possible post-2020 global biodiversity framework should also add the **LBO** in the brackets under Information

Under the Draft Recommendations, *The Conference of the Parties*, paragraph 7, we would like to add the following:

7. *Invites* the General Assembly of the United Nations to convene a high-level biodiversity summit at the level of Heads of State/Heads of Government in 2020, **to also include at least one member for each region of the IIFB**, in order to raise the political visibility of **levels of contributions to the conservation of** biodiversity, **including those from the IPLCs** as a contribution to the development of a robust post-2020 global biodiversity framework;

In Annex I Indicative chronology of key activities leading to the consideration of the post-2020 global biodiversity framework, the IIFB suggests to add in the table under November 2019 and May 2020, to add the following:

November 2019	SBSTTA-23 reviews the draft of GBO-5, the LBO2 and the IPBES global assessment and other relevant information and prepares a recommendation on the implication of these and other completed thematic assessments of IPBES for the post-2020 global biodiversity framework
May 2020	GBO-5 and the complementing LBO2 documents to be published on the basis on the 6 th national reports, updated NBSAPS the IPBES Assessments and information from the Biodiversity Indicators Partnership



In Annex table 2 - Indicative budget for key activities leading to the consideration of the post-2020 global biodiversity framework by COP 15, COP-MOP 10 and COP-MOP 4, The IIFB is encouraged that consultation workshops have been accommodated in the indicative budget for key activities and welcomes the participation of IPLCs in the Regional Consultation Workshops. However, we stress that it is equally important that ***IPLCs are also participating in the Dialogue Workshops and Global Consultation Workshops*** as well. Therefore, we would like to add the following in the table:

Regional Consultation workshops	10 regional consultation workshops (2 per region) will be held. These workshops would be open to Parties, other governments, <u>indigenous peoples and local communities</u> , business stakeholders, youth groups, civil society, academia and other relevant organizations and stakeholders from the relevant regions.
Dialogue workshops	Dialogue workshops (such as the Bogis-Bosey Dialogues for Biodiversity) with the participation of experts and representatives from Parties, <i>IPLCs and other</i> observers.
Global consultation workshops	A global consultation workshop focused on evidence from the natural, economic and social sciences and <i>IPLCs with</i> traditional knowledge systems related to the post-2020 global biodiversity framework would be held. An event, such as the Trondheim Biodiversity Conference could be used to convene the consultation.

We request the support of Parties for these changes.
